Section 2. Hazards Identification

Clear colorless liquid or white solid; no odor.
 CAUTION! Slightly toxic by ingestion. Target organs: None known
 This material is considered hazardous by the OSHA Hazard Communication Standard (29 CFR 1910.1200)

Section 3. First Aid Measures

Eyes: Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally.

Skin: Immediately flush skin with excess water for 15 minutes while removing contaminated clothing. Ingestion: Call Poison Control immediately. Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink. Induce vomiting immediately.

Inhalation: Remove to fresh air. If not breathing, give artificial respiration.

Section 4. Fire Fighting Measures

Noncombustible solution. When heated to decomposition, emits acrid fumes. 0 Protective equipment and precautions for firefighters: Use foam or dry chemical to extinguish fire. 1 0 Firefighters should wear full fire fighting turn-out gear and respiratory protection (SCBA). Cool container with water spray. Material is not sensitive to mechanical impact or static discharge.

Use personal protection recommended . Isolate the hazard area and deny entry to unnecessary and unprotected personnel.

Contain spill with sand or absorbent material and place material in a sealed bag or container for disposal. Wash spill area after pickup is complete.

Section 6. Handling and Storage

Handling: Use with adequate ventilation and do not breathe dust or vapor. Avoid contact with skin, eyes, or clothing. Wash hands thoroughly after handling.

Storage: Store in General Storage Area [Green Storage] with other items with no specific storage hazards. Store in a cool, dry, well-ventilated, locked store room away from incompatible materials.
