Section 2. Hazards Identification
<p>Clear red solution; very slight odor.</p> <p>CAUTION! Moderately toxic by ingestion and possible carcinogen. Target organs: Kidneys, lungs, thyroid.</p> <p>This material is considered hazardous by the OSHA Hazard Communication Standard (29 CFR 1910.1200)</p>
Section 3. First Aid Measures
<p>Eyes: Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally.</p> <p>Skin: Immediately flush skin with excess water for 15 minutes while removing contaminated clothing.</p> <p>Ingestion: Call Poison Control immediately. Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink. Induce vomiting immediately.</p> <p>Inhalation: Remove to fresh air. If not breathing, give artificial respiration</p>
Section 4. Fire Fighting Measures
<p>Noncombustible solution. When heated to decomposition, emits acrid fumes.</p> <p>Protective equipment and precautions for firefighters: Use foam or dry chemical to extinguish fire. 20 Firefighters should wear full fire fighting turn-out gear and respiratory protection (SCBA). Cool container with water spray. Material is not sensitive to mechanical impact or static discharge.</p>



Section 5. Accidental Release Measures

Isolate the hazard area and deny entry to unnecessary and unprotected personnel. Contain spill with sand or absorbent material and place in sealed bag or container for disposal. Ventilate and wash spill area after pickup is complete.

Section 6. Handling and Storage

Handling: Use with adequate ventilation and do not breathe dust or vapor. Avoid contact with skin, eyes, or clothing. Wash hands thoroughly after handling.

Storage: Store in General Storage Area [Green Storage] with other items with no specific storage hazards. Store in a cool, dry, well-ventilated, locked store room away from incompatible materials.
