<p>White crystalline powder, no odor.</p> <p><b>WARNING!</b></p> <p>Moderately toxic by ingestion, body tissue irritant, and possible carcinogen. Target organs: Kidneys, central nervous system, blood forming organs.</p> <p>This material is considered hazardous by the OSHA Hazard Communication Standard</p>
Section 3.First Aid Measures
<p><b>Eyes:</b> Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally</p> <p><b>Skin:</b> Immediately flush skin with excess water for 15 minutes while removing contaminated clothing</p> <p><b>Ingestion:</b> Call Poison Control immediately. Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink Induce vomiting immediately</p> <p><b>Inhalation:</b> Remove to fresh air. If not breathing, give artificial respiration.</p>
Section 4. Fire Fighting Measures
<p>Non-flammable solid. When heated to decomposition, emits acrid fumes.</p> <p>Protective equipment and precautions for firefighters: Use foam or dry chemical to extinguish fire. Firefighters should wear full fire fighting turn-out gear and</p>



respiratory protection (SCBA). Cool container with water spray.
