Section 2. Hazards Identification

Appearance: blue-green solid.

Warning! Harmful if swallowed. Causes eye and skin irritation. May cause

respiratory tract irritation.

Target Organs: Blood, kidneys, central nervous system, liver, gastrointestinal

Potential Health Effects

Eye: Causes eye irritation.

Skin: Causes skin irritation. May be harmful if absorbed through the skin.

Section 3.First Aid Measures
